FOR F.Y 2021-22.


Memo:

The process of Selection & Rate Contracting under framework agreement for the procurement of machinery, equipment, instruments & other hospital supplies for the year 2021-22 has been completed and approved rates have been uploaded on the official website of the Health Department.

However, enclosed is the approved list of machinery, equipment, instruments & other hospital supplies alongwith the names and addresses of the suppliers (manufacturer/importers) for your information with the following instructions that:-

1. Your offices shall place supply orders of the required items directly to the firms to the effect that before issuing supply orders to the firms, your offices shall ensure the following.
 - i. Availability of Human Resource (HR).
 - ii. Availability/Completion of infrastructure.
 - iii. Availability of Power (Electricity).
 - iv. There is no dumping of the said equipment.
2. The rates shall be valid till 30th June 2022.
3. A copy of the supply order and supply completion certificate shall be sent to the Procurement Cell DGHS Office Peshawar for needful. Any complaint regarding supplies/suppliers shall be communicated to the Procurement Cell DGHS Office Peshawar within the contractual time frame positively, failing which the CDRs of the successful suppliers will be released and this office shall bear no responsibility in this respect.
4. Upon receipt of the suppliers, your office shall immediately arrange inspection of the supplies as per approved protocols.
5. Upon successful completion of supply of the required items in line with the clauses of contract agreement, the concerned officers will be responsible to ensure timely payment to the firm. Failing which strict action will be taken against the defaulting officers in person.
6. Payment shall not be released to the firm without submission of contract execution certificate duly signed by the undersigned.
7. Suppliers shall be bound to supply their approved items to the health institutions under your jurisdictions as per attached contract agreement.
8. The successful bidders shall submit performance security @ 10% to your office in the shape of CDR of the amount of supply order placed by your offices.

You are hereby directed to ensure implementation of this agreement in letter of spirit.
