

1. A firm/consulting organization will be selected under rule 23 (b) **QUALITY AND COST BASED SELECTION** method and procedures described in this RFP, in accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Procurement Rules 2014.
2. Mandatory Bid Security / Earnest Money amounting to a flat rate of Rupees One Million only (Rs. 1,000,000/-) from each bidder in the shape of Call Deposit Receipt (CDR) in the favor of the Managing Director, Health Foundation required to be submitted along with the Financial Bid within its sealed envelope. An affidavit, shall be submitted with technical bid; to the effect that the requisite CDR (1,000,000/-) in original is attached within the financial bid
3. The Proposals must be delivered by hand or through courier to the office of the Health Foundation with office address at 46-E Jamal Ud Din Afghani Road University town Peshawar on or before **13/05/2020 at 1:00 PM** which will be opened on the same day at **2:00 PM** in presence of bidders or their representatives.
4. Each Hospital may consider as a separate project and the firm must submit separate proposals for each hospital.
5. Bids after due date and time shall not be considered.
6. The bidding shall be conducted through Quality and Cost based selection method comprising a single package containing technical and Financial proposals separately. Each envelope shall be marked as **"TECHNICAL PROPOSAL"** and **"FINANCIAL PROPOSAL"**
7. Pre-bid Meeting will be held on 05-05-2020 at 10:00 am in the Committee Room of the Health Foundation.
