Request for proposal notice is open to all Consultants/Joint venture of consultants who are Registered with Pakistan Engineering Council and Khyber Pakhtunkhwa Revenue Authority (KPRA) in line with **rule no.37A** of Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) and also enlisted under **rule no. 32A**. 4. The Consultant will be selected under the Quality & Cost Based Selection (QCBS) method and procedures described in this RFP, in accordance with the KPPRA rules.
