The DHO concerned is requested to submit the status of joining reports of newly appointed GAVI Vaccinators within three (03) days to Directorate General Health Services, Khyber Pakhtunkhwa. Moreover, performance reports alongwith salary claims of the joined Vaccinators may be shared on monthly basis with this office.

Terms and Conditions:

1. The appointment is purely on **Fixed Pay Package (Non-transferable)** for a period of **six months** under GAVI Support Program for COVID vaccination.
2. The contract can be terminated any time without assigning any reason as per project policy.
3. The services of above Vaccinators shall be utilized only for COVID vaccination.
4. The appointees shall produce **Medical Fitness Certificate** from the office of the Medical Superintendents of their respective DHQ Hospitals.
5. Salaries will be released after verification of all the documents and fulfillment of other formalities.
6. If the appointee wishes to resign from the service, prior notice of 30 days should be submitted otherwise salary of 30 days have to be deposited in lieu thereof.
7. The employee are entitled of two days casual leave on full pay for every month on duty rendered.
8. The employee shall not be entitled to undergo any kind of training inside the country or abroad.
9. The concerned DHO shall be personally responsible for verification of documents/certificates/degrees of the appointees from the relevant forum and his/her salary shall not be released till the verification of the documents.
10. They will serve in any district assigned to them by the competent authority.
11. In case of any information, testimonial or any other documents found fake/bogus, the contract employee shall be responsible for it and FIR will be lodged against the defaulters.
12. If any appointee found to be a Civil Servant, his/her contract shall be terminated immediately.
13. If he/she accepts the offer on the above mentioned terms and conditions, he/she is directed to submit arrival report to concerned DHO Office within 02 days positively. Surety Bond of 100 rupees on the Judicial Stump Paper along with Medical Fitness Certificate must be submitted with the concerned DHO at the time of arrival on duty station.
