Within 15 Days

Upon delay in supply from Fifteen to Thirty (15 to 30) days, a lump sum penalty amounting to Five per cent (05%) of the total quoted price of such goods.

- Immediately debarring the Supplier from future participation and business for at least next two (02) calendar years with the Government of Khyber Pakhtunkhwa or any other health institution, project and / or Program directly or indirectly run or implemented by or through the provincial Health Department or Purchasing Agencies in the Province, as defined in the SBDs.
- Initiating the process for and recommending for permanent blacklisting of the Supplier with the Purchasing Agencies.
