**TERMS AND CONDITIONS:-**


- The terms and conditions of their service will be governed under the Khyber Pakhtunkhwa Civil Servants Act, 1973 and rules made there-under.
- Their services will be liable for termination on one month's notice from either side. In case of resignation without notice, two month's salary/allowances shall be refunded to Government.
- The appointee should accept their offer within thirty (30) days of the issuance of this notification. In case candidate fails to join the post after one month of issuance of this notification, their appointment will expire automatically and no subsequent appeal etc: shall be entertained.
- They will be on probation for a period of one year, extendable for another year in terms of Rule-15 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.
- They will be governed under such rules and regulations as may be issued from time to time by the Government.
- Their services can be terminated at any time, in case their performance is found unsatisfactory during probation period. In case of misconduct, they will be proceeded against the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011.
- Arrival report should be submitted by the concerned officer to PHSA.
- No TA/DA will be allowed to the appointee for joining the duty.
- They are also required to register on HRMIS of Health Department with the Deputy Director HR o/o the Director General Health Services Peshawar.
- If they accept the post on the above terms & conditions, they should submit arrival report in PHSA within thirty (30) days of the issuance of this notification.
