Subject: **Blacklisting**

In continuation of this office order No. 1725/Admn/DHQH/KK dated 31-08-2023, you have been continuously found to be involved / indulged in corrupt and fraudulent practices over the past few years and this hospital / the undersigned has sufficient evidences against you in order to take appropriate action of permanently blacklisting you from further participating in procurement proceedings under Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014. You have continuously remained involved in;

- i) Coercive practice by threatening to harm in order to impair the process.
- ii) Collusive practices along with your brothers who are doing same businesses in the market in order to dodge the procuring entity by giving prices at artificial and noncompetitive levels for any wrongful gains to impair or harm the process.
- iii) Corrupt practices by approaching the undersigned and other staff members to influence the procurement process for wrongful gain which was / has been strongly refused to your utter disappointment resulting in vilification campaign in social media, harassment and threats hurled by you.
- iv) Fraudulent practice by knowingly misleading the procuring entity and the Health Department in order to obtain a financial or other benefit.
- v) Obstructive practice by threatening to harm directly and indirectly to influence the procurement process. You have deliberately falsified at various forums by producing an inquiry report which was declared null & void by the Health Department vide notification No. SOH (E-V) / 2-2 / 2022 dated 24-10-2022. You have intentionally given false statements to the inquiry committee constituted by the Health Department dated 24-10-2022 as mentioned above and the inquiry committee has declared all your allegations as totally baseless.
- vi) An attempt to physically attack the undersigned along with your brothers on 05-08-2022 which was reported to the local police and the Health Department. You have chased and trespassed the undersigned on 13-07-2023 in Peshawar in order to harass and threaten the undersigned for influencing the ongoing procurement process.

Despite of the above stated reasons you were counselled on several occasions and were advised to refrain from such acts but of no avail. Therefore in view of the above and so many other instances wherein you have tried to cross every limit for your nefarious motives, the undersigned has been left with no other choice but to take action against you under Rule 44 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014 by permanently blacklisting you from participating in the procurement proceedings in the larger public interest.
