Reference to supply order no. 1617/Admn/DHQH/KK dated 21/08/2023, we entered into a contract with your company for the supply of print paper sheets of a specific quality and brand, as well as various stationery items. You failed to meet the agreed-upon quality standards and timely deliveries.

Your supply of print paper sheets was first rejected by our inspection committee, and you were subsequently warned through Letter No. 1761/Admn/DHQH/KK dated 05/09/2023 to supply print sheets that met the specified quality and the remaining stationery items. However, on your second attempt, you failed to meet the required quality standards for the print paper sheets, resulting in their rejection once again. Despite our warnings and attempts to rectify these issues through Letter No. 1902/Admn/DHQH/KK dated 19/09/2023, in which you were explicitly instructed to supply the specified quality and the remaining stationery items, you failed for the second time. Moreover, you were warned through a letter no. 1762/Admn/DHQH/KK dated 05/09/2023 to provide affidavit in contract of Car-Parking but you failed to provide it.

Instead of addressing the quality and delivery issues constructively, you resorted to threats and abusive language towards our committee members. Given your consistent inability to meet our requirements and your unprofessional conduct we have no choice but to blacklist your company from any future business dealings.

This decision is effective immediately, and we will no longer accept any further deliveries or communications from your company. Any attempts to circumvent this blacklisting will result in legal action.
