TERMS AND CONDITIONS:

Their appointment is subject to the following terms and conditions:

1. The appointment will be purely on adhoc basis for a period of one year or till the arrival of the recommnedees of Public Service Commission Khyber Pakhtunkhwa whichever is earlier.

- 2. The employees will be entitled to receive salary equal to the minimum of (BS-18) in addition to other allowances as admissible to Civil Servants of the same scale.
- 3. On the expiry of one year or on arrival of the selectees from Khyber Pakhtunkhwa Public Service Commission whichever is earlier, services of the employee shall stand automatically dispensed with.
- 4. No extension will be granted on the expiry of the said Adhoc period.
- 5. The employees shall be entitled to medical treatment as admissible under the Khyber Pakhtunkhwa Govt. Servants Medical Attendance Rules, 2016.
- 6. The employees shall be entitled to two days casual leave on full pay for every month on duty rendered.
- 7. The employee shall not be entitled to undergo any kind of training in side the country or abroad.
- 8. Charge report should be submitted to all concerned.
- 9. Their services are liable to termination on one month's notice from either side. In case of leaving the department without notice, their one month pay/allowance shall be forfeited to the government.
- 10. Absence from duty, for a single day, shall be considered as misconduct and violation of the agreement and in that case the Health Department is competent to terminate the agreement without any prior notice.
- 11. The employee shall not be required to contribute CP/GP Fund.
- 12. The Adhoc appointment is non-pensionable and is without gratuity.
- 13. The employee is not permitted to do private practice, open any clinic, private dispensary or have any interest in any such private facility.
- 14. The Adhoc appointment shall be subject to medical fitness and verification of antecedents as well as testimonials.
- 15. The appointment is for Saidu College of Dentistry, Saidu Sharif Swat. They will have to serve at the place of posting and their services are not transferable to any other station.
- 16. In case, the employee is found undergoing training in any institution sponsored by any health project of the Govt. either provincial or federal or private sector and in that regard signed any agreement with the project, his/her appointment shall stand terminated.
- 17. Before handing over the charge, once again their documents may be checked and verified from the concerned issuing agencies by the Principal Saidu College of Dentistry Swat, being the controlling officer. If they have not acquired the relevant qualification as per rules, they may not be handed over the charge of the post and the case may be reported to the Secretary Health for withdrawal of the appointment order.
- 18. The Principal Saidu College of Dentistry Swat, being the controlling Officer, shall be personally responsible for verification of documents/certificates/Degree/Experience Certificates of Adhoc appointee/doctor and his/her salary shall not be released till the verification of the academic documents/certificates/degree from the concerned boards/universities within fifteen days (15) positively.
- 19. In case of any fake information/testimonial or any other documents, the adhoc employees shall be responsible and FIR will be lodged against the defaulters.
- 20. If this offer of appointment order with the above terms and conditions is acceptable, the appointee shall execute an agreement with the department on judicial stamp paper containing all these terms and conditions.
- 21. The above named doctors are required to report for duty within fifteen (15) days from the date of issuance of this Notification, failing which this offer of appointment will stand automatically cancelled.
