TERMS AND CONDITIONS:-

The terms and conditions of his service will be governed under the Khyber Pakhtunkhwa Civil Servants Act, 1973 and rules made there-under.

His service will be considered regular and will be entitled to General Providert Fund in such a manner and on such rate as may be prescribed by the Govt. of Khyber Pakhtunkhwa Civil Servants (Amended) Act, 1973.

wi. His Services will be liable for termination on one month's notice from either side. In case of resignation without notice, two month's salary/allowances shall be refunded to Government.

The appointee should accept this offer within thirty (30) days of the issue of this notification. In case he fails to join the post after one month of issue of the Notification, his appointment will expire automatically and no subsequent appeal et a shall be entertained.

He will be on probation for a period of one year, s. lendable for another year in terms of Rule-15 of the Khyber Pakh unkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989.

He will be governed under such rules and regulations as may be issued from ome to time by the Government.

His services can be terminated at any time, in case his performance is foun. unsatisfactory during probation period. In case of misc induct, he will be proceeded against the Khyber Pakhtunkhwa Government Ser ants (E&D) Rules, 2011.

He is also required to register on HRMIS of Health Department with the Deputy Director HR o/o the Director General Health Services Peshawar.
