SOH-I/HD/1-891/2021: Consequent upon the recommendations of the Khyber Pakhtunkhwa Public Service Commission vide letter No. PSC/SR-V012994 dated 11.10.2021, the Competent Authority (Chief Minister Khyber Pakhtunkhwa) is pleased appoint Dr. Munammad Ifham khan Jadoon S/O Muhammad Anwar Village and Post Office. Sharif Swat with immediate effect, on the terms and conditions mentioned below:-

TERMS AND CONDITIONS:-

The terms and conditions of his service will be governed under the Khy. Pakhtunkhwa Civil Servants Act, 1973 and rules made there-under.

ii. His service will be considered regular and will be entitled to General Provident Fund in such a manner and on such rate as may be prescribed by the Govt. of Khyber Pakhtur.khwa Civil Servants (Amended) Act, 1973.

iii. His Services will be liable for termination on one month's notice from either side. In case of resignation without notice, two month's salary/allowances shall be refunded

iv. The appointee should accept this offer within thirty (30) days of the issue of this notification. In case he fails to join the post after one month of issue of this Notification, his appointment will expire automatically and no subsequent appeal expire shall be entertained.

He will be on probation for a period of one year, extendable for another year in term s of Rule-15 of the Klyber Pakhtunkhwa Civil Servarits (Appointment, Projection 3 Transfer) Rules, 1989.

He will be governed under such rules and regulations as may be issued from time time by the Government.

vii. His services can be terminated at any time, in case his performance is for unsatisfactory during probation period. In case of misconduct, he will be proceed against the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011. viii.

Arrival report should be submitted by the concerned doctor to this department.

No TA/DA will be allowed to the appointee for joining the duty. ix.

He is also required to register on HRMIS of Health Department with the Departy X. Director HR o/o the Director General Health Services Peshawar.

If he accepts the post on the above terms & conditions, he should submit array xi. report in Health Department within thirty (30) days of the issuance of this notification
