## TERMS AND CONDITIONS:

- i. Their services will be considered regular and are entitled to *General Provident Fund* in such a manner and at such rates as may be prescribed by the Govt. under Khyber Pakhtunkhwa Civil Servants (Amendment)t Act, 2013.
- ii. Their Services will be liable for termination on one month's notice from either side. In case of resignation without notice, two month's salary/allowances shall be refunded to Government.
- iii. The appointees should accept the officer within thirty (30) days of the issue of this notification. In case any candidate fails to join the post after one month of issue of this Notification, his/her candidature will expire automatically and no subsequent appeal etc: shall be entertained.
- iv. They will be on probation for one year.
- v. They will be governed under such rules and regulations as may be issued from time to time by the Government.
- vi. Their services can be terminated at any time, in case their performance is found unsatisfactory during probation period. In case of misconduct, they will be proceeded against the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 and the Rules framed there under from time to time.
- vii. Charge reports should be submitted by the concerned doctors.
- viii. No TA/DA will be allowed to the appointees for joining the duty.
- ix. They are also required to register on HRMIS of Health Department with the Deputy Director HR o/o the Director General Health Services Peshawar
- x. If they accept the post of the above terms & conditions, they should submit arrival report in Health Department within thirty (30) days of the issuance of this notification.
