### **NOTIFICATION**

Peshawar Dated, the 29<sup>th</sup> October, 2020.

NO. SOH(MTI)/HD/1-1/MTI/2020:- In exercise of the powers conferred by section 23 of the Khyber Pakhtunkhwa Medical Teaching Institutions Reforms Act, 2015 (Khyber Pakhtunkhwa Act No. IV of 2015) read with sub-section (1) of section 16A thereof, the Government of Khyber Pakhtunkhwa is pleased to direct that in the Khyber Pakhtunkhwa Medical Teaching Institutions Appellate Tribunal Rules, 2020, the following amendments shall be made, namely:

### **AMENDMENTS**

1. In rule 3,-

(a) in sub-rule (1), for clause (a), the following shall be substituted, namely:

“(a) a Chairman, who shall be a retired Judge of the High Court, to be appointed by Government in consultation with the Chief Justice, Peshawar High Court; and”;

(b) for sub-rule (3), the following shall be substituted, namely:

“(3) The upper age limit for the Chairman shall be sixty eight (68) years, whereas for the members, the upper age limit shall be sixty five (65) years.”.

2. For rule 4, the following shall be substituted, namely:

**“4. Search and Nomination Committee.---**(1) There shall be Search and Nomination Committee to recommend nominees to Government for appointment as Chairman and members of the Appellate Tribunal.

(2) The Search and Nomination Committee shall consist of the following, namely:

Rule 5 shall be deleted.

3. For Rule 6, the following shall be substituted, namely:

**“6. Tenure of office.---**(1) The Chairman shall hold office for a term of three (3) years or till the age of sixty eight (68) years, whichever is earlier.

(2) The members shall hold office for a term of three (3) years or till the age of sixty five (65) years, whichever is earlier.

(3) Government may extend the term of office of the Chairman for another term or till the age of sixty eight (68) years, whichever is earlier.

(4) Government may extend the term of office of the members for another term or till the age of sixty five (65) years, whichever is earlier.”
