The bidding shall be conducted under RFQ procedure as per World Bank procurement regulations. Quantity may increase or decrease by 20% at the time of issuance of purchase order.  - The supplier must be income Tax and Sales Tax registered and must be on active taxpayer list of FBR prior to issuance of purchase order.
 - Evidence of similar supplies in the past five (05) years is required.
 - Supplier should have a documented track of completing at least two (2) similar assignments, involving the supply of a comparable scale. Documentary proof to be provided.
2. **Quotations**
 - Prices shall be quoted in PKR, inclusive of all applicable taxes, duties, and delivery charges.
 - Quotations must remain valid for at least 60 days from the submission deadline.
3. **Transportation and Delivery**
 - The supplier is solely responsible for safe transportation, loading, unloading, and stacking of goods until delivery at the designated addresses.
 - All handling and storage must comply with current Good Storage Practices.
 - Any deviation may result in rejection of supplies, which will be returned at the supplier's cost, with no liability on the Procuring Agency.
4. **Delivery Period**
 - Goods must be delivered within 20 days of the issuance of the purchase order, unless otherwise specified.
5. **Inspection and Acceptance**
 - Supplies will be inspected upon delivery. Non-compliant or defective goods must be replaced at no additional cost to the Procuring Agency.
6. **Warranty**
 - The supplier shall guarantee that goods are free from defects and meet specifications. Any defective items must be replaced promptly.
7. **Payment**
 - Payment will be made in PKR, 100% upon delivery and acceptance of goods.
8. **Evaluation and Award**
 - The contract will be awarded to the supplier offering the lowest evaluated quotation that meets all technical and delivery requirements.
 - The Procuring Agency reserves the right to reject any or all quotations without assigning reason.
