
Subject:- **APPROVED RATES OF CATEGORY C & D (SAMPLE BASED) ITEM
FOR THE YEAR 2022-23.**

Continuation this Directorate letters No.1432-1507/Proc.Cell dated 29.11.2022 and No.1685-1755/Proc.Cell dated 28.12.2022; enclosed are the approved rates of category C & D (sample based) items along with names and addresses of the suppliers under frame work agreement for the procurement of for the year 2022-23 for your information and further necessary action. The approved lists Category C & D (Sample Based) items have also been uploaded on the official website of Health Department with the following instructions that:

1. Your offices shall place supply orders of the required items directly to the firms to the effect that before issuing supply orders to the firms, your offices shall ensure the following:
 - i. Availability of Human Resources (HR)
 - ii. Availability/Completion of Infrastructure
 - iii. Availability of financial resources
 - iv. Availability of Power (Electricity)
 - v. There is no dumping of the said equipment
2. The Rates shall be valid till 30th June, 2023.
3. The successful bidders shall submit performance security @ 10% to your offices in the shape of CDR of the total amount of supply order placed by your offices.
4. A copy of the supply order and supply completion certificate shall be sent to the Procurement Cell of this Directorate for needful. Any complaint regarding supplies/suppliers shall be communicated to the Procurement Cell DGHS Office Peshawar within the contractual time frame positively.
5. Upon receipt of the supplies, your office shall immediately arrange installation and inspection of the supplies as per approved protocols.
6. Suppliers shall be bound to supply their approved items to the health institutions under your jurisdiction as per attached contract agreement.
7. Upon successful completion of supply of the required items in line with the clauses of contract agreement, the concerned officers will be responsible to ensure timely payment to the firm; failing which strict action will be taken against the defaulting officers in person.
8. Deduction of all applicable taxes/duties from the suppliers at the time of payment.


You are hereby directed to ensure implementation of this agreement in letter and spirit.
