Notice for Mandatory Registration of Blood Establishments in Public Sector, MTIs and Private Sector

Applications are invited from all public sector institutions, Medical Teaching Institutions (MTIs), and private sector organizations for the mandatory registration of their respective blood establishments in accordance with the Khyber Pakhtunkhwa Blood Transfusion Authority Act.

This step is essential to ensure the safe, regulated, and efficient operation of all blood centers across the province, in the best interest of the public. The application form can be downloaded from the official link provided (www.healthkp.gov.pk).

A non-refundable pay order of PKR 1,500 in the name of Chief Executive Officer, Khyber Pakhtunkhwa Blood Transfusion Authority must be submitted along with the completed registration form. The duly filled registration form, along with the non-refundable registration fee, must reach the office of the Blood Transfusion Authority, Phase-IV, Hayatabad, Peshawar, on or before 30th April, 2025 during official working hours. Registration of all blood establishments is mandatory under the policy of the Government of Khyber Pakhtunkhwa to ensure compliance with national standards for blood transfusion services. This effort is aimed at safeguarding the health and well being of the people of the province.
