**PROCUREMENT OF SERVICES OF PRIVATE LABORATORIES FOR RT-PCR TESTING TO
COPE WITH COVID 19 EMERGENCY (2020)**

1. In Pursuance of the declaration of Emergency vide notification NO.SO (Esst) RR&SD/3-5/2019 under National Disaster Management Act of Khyber Pakhtunkhwa due to emerging cases of Corona Virus (COVID-19) and in light of decision of special meeting of the Cabinet on 13-03-2020, exemption has been granted under section 14(1) of KPPRA Act, 2012 in respect of procurements related to Corona Virus (COVID-19) for government departments/ public bodies/agencies.
2. Directorate General Health Services (DGHS), Ex-FATA Secretariat Warsak Road, Peshawar invites sealed bids for urgent Testing to acquire services of well established, registered & reputed laboratories to conduct RT-PCR COVID-19 testing/ testing solution for Covid-19 on QCBS Mode (Quality & Cost Based System) with 80% (Technical) & 20% (Financial) weightage as per WHO standards fulfilling the following criteria;
 - a. Availability of Trained staff including Microbiologist
 - b. Availability of adequate Machine & Equipment
 - c. Availability of functional Biosafety Cabinet of BSL II grade
 - d. Availability of Proper Waste management Plan and Structure
3. Bidding for emergency Procurement of Covid-19 shall be conducted through Single Stage –Two Envelopes Procedure comprising a single package containing two envelopes as per KPPRA Rules-2014. Each envelope shall contain separately Technical and financial bid clearly marked in bold & legible letters. The firms are bound to provide complete information of the bidder along with its postal as well as valid email address and phone number/s on each of the respective envelope.
4. The successful bidder shall be responsible for maintaining and standardizing the quality of Test Report & procedures.
5. Interested bidders can obtain the RFP document from the Procurement Cell of the Directorate General Health Services Khyber Pakhtunkhwa Ex-FATA Secretariat Warsak Road Peshawar and electronically from the Official Website of Health www.HealthKP.gov.pk & www.dghskp.gov.pk.
