EXPRESSION OF INTEREST

Keeping in view the widespread poverty and High out of pocket expenditure, the Government of Khyber Pakhtunkhwa launched the Social Health Protection Initiative in 2016 for the 100,000 households of the province.

Due to the tremendous success of the programme, the Government of Khyber Pakhtunkhwa expanded the coverage of the programme to 100% population in 2020 with the brand Name Sehat Card Plus. Currently around 7.6 million families including all the individuals of the whole province are being targeted. Annual premium cost is approximately 23 billion.

With 100% population coverage, Sehat Card Plus has become an all-inclusive programme offering almost all the inpatient care, free of cost to all the residents of the province, making Khyber Pakhtunkhwa the only region in Asia to achieve the Universal Health Coverage.

Committed to improve the health status of the people and to enhance the Health Financing for efficient service delivery the Health Department, Government of Khyber Pakhtunkhwa invites **“Expression of Interest (EOI)”** for implementing the “Health Insurance Programme” for the Government Employees of Khyber Pakhtunkhwa from well reputed and registered Insurance Firms/companies having expertise in the field of Health Insurance. The firm/company shall be selected in accordance with the "Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.

Interested Firms/Companies will be expected to provide explicit information and evidence of their qualification to perform this assignment, including;

- Experience of implementation of health insurance schemes for general public, private groups, public or private sector organizations, corporate bodies or any other such entity;
- Financial and Operational Systems to implement the programme;
- Governance arrangements and Management structure;
- Capability in actuarial assessments, costing and pricing of health services; and
- Experience of collaborative working with provincial and district governments.

The Firms/Companies can make Consortiums, or Joint Ventures (JVs) to enhance their capabilities, however, the lead firm must be clearly mentioned in the EOI. All the interested firms must be registered with Khyber Pakhtunkhwa Revenue Authority.

To discuss the various elements of the scheme, a pre-EOI meeting will be held on **May 31, 2022, at 11:00 AM** in the Conference Room of Health Department. The Minister Health will chair the meeting. All the prospective interested organizations are invited to attend the meeting.

Sealed EOIs in hard as well as in soft form (PDF format) must be delivered to the address given below by or before **03:00 PM on June 20, 2022**. The EOI will be opened on the same day at **03:30 PM**.
