## ORDER:


WHEREAS, M/S Unisa Pharmaceutical Industries (Pvt) Ltd., Nowshera, whose full address is given below, has been found guilty of gross misconduct and fraudulent practices by submitting fake, forged, and misleading tender approval documents as part of their technical bid for the Government MCC Tender for FY 2024-25.

AND WHEREAS, the said documents, upon verification from the concerned Procuring entities, and District Health Authorities of the Government of Punjab, were categorically declared to be fraudulent vide the official correspondences: Letter No. 12394/MS, dated 14-11-2024, Letter No. 4552/PC, dated 14-11-2024, Letter No. 2566/A&A, dated 16-11-2024, Letter No. 5400/RTH, dated 16-11-2024, Letter No. 7043/B&A, dated 20-11-2024, Letter No. 6916/Estt/DHA, dated 21-11-2024, and Letter No. 29082/CEO(DHA), dated 23-11-2024.

AND WHEREAS, the firm was served an opportunity of personal hearing in accordance with due process; however, the firm utterly failed to justify or defend its actions, thereby admitting liability through silence and failure of justification.

NOW, THEREFORE, in light of the proven misconduct and blatant violation of Section 29 of the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Act 2012, read with Rule 44(1) of the KPPRA Rules 2014, and in accordance with the Debarment/Blacklisting Guidelines notified vide Letter No. 2440-2500/Proc. Cell dated 30-08-2018, as well as clauses 2.4, 34.1 of the Instructions to Bidders (ITB), GCC 24.1, and Section 4 of the Integrity Pact enshrined in the approved Bid Solicitation Documents of Government MCC FY 2024-25, the firm, M/S Unisa Pharmaceutical Industries (Pvt) Ltd. is hereby debarred and blacklisted from participating in any procurement process, tendering activity, or contract for the financial year FY 2024-25, effective immediately and, the firm's bid security/CDR amounting to PKR 10,00,000/- (Ten Lakh Rupees) shall be forfeited and deposited to the Government Treasury, as a penalty for its fraudulent conduct.
