Interested Bidders must submit sealed bids to the office of Vector-borne diseases (VBDs), DGHS, Govt of Khyber Pakhtunkhwa on or before 11:00 AM sharp, 19th May, 2025, which will be opened on the same day at 11:00 AM in the presence of those bidders or their representatives, who choose to attend the process. Bid submitted after 11:00 AM shall not be entertained.

The bid must be accompanied with Bid Security as per bid data sheet in the shape acceptable as per KPPRA in the name of Director Vector-borne diseases (VBDs), DGHS, Govt of Khyber Pakhtunkhwa and the bid security shall be from the account of the firm/bidder who submits the bid. If Bid Security submitted in other shape except mentioned in the KPPRA Act, 2012 and Rules, 2014, shall not be acceptable and will lead to rejection of the bid.
- Bidders are required to submit the unit price of the quoted item on format as prescribed in Bid Solicitation
 Documents. Quotation with hand written, cutting and over writing shall not be accepted to the extent of
 that particular quoted item.
- Bidders are required to offer the most competitive rate of their items, as negotiations / discounts on quoted rates are not allowed under the rules.
