9. Moreover, if the credentials of any Medical Officer are found fake and/or forged the Department will take legal action against such individuals.
10. The doctors concerned are required to report for duty within seven days from the date of issuance of this notification failing which the appointment will stand automatically cancelled, in case of non-compliance in the stipulated period stated above.


