Quotation must be valid for 30 days, signed, stamped and typewritten.
Used and refurbished items will not be acceptable
Equipment must be delivered and installed in Peshawar at the warehouse located at Warsak Road within 05 days of issuance of Purchase Order/Notification of Award.
Prices shall be fixed and bid price should be in Pak Rupees.
