The offer or must be an agent/dealer or reseller of required item in Pakistan, with a minimum of one (1) years of experience in supplies.

Supplier/dealer should have a documented track of completing at least one (1) similar assignments, involving the supply of a comparable scale. Documentary proof to be provided.

The offeror must be income Tax and Sales Tax registered and must be on active tax payer list of FBR prior to issuance of purchase order.

One-year warranty should be provided.

Quotation must be valid for 30 days, signed, stamped and typewritten.

Used and refurbished items will not be acceptable.

Equipment must be delivered and installed in Peshawar at the warehouse located at Warsak Road within 05 days of issuance of Purchase Order.
