- Bidding will be conducted through **Single Stage – Two Envelopes Bidding procedure** as per Rule 6 (2)(b) of the **Khyber Pakhtunkhwa Procurement of Goods, Works and Services Rules 2014**.
- Bids must be delivered at the address given below at or before **5:00 pm on 9th June, 2022 (Thursday)**. Bid Security / Earnest Money of **2%** of the total bid value in the shape of Demand Draft (DD)/Call Deposit Receipt (CDR) is required to be submitted with the financial bid. Late bids will be rejected. Bids will be opened in the presence of the bidders' or their representatives, who choose to attend at the address below at **9:30 am on 10th June, 2022 (Friday)**.
- Financial Bids will be opened in the presence of the bidders' or their representatives, who choose to attend at the address below at **3:30 pm on 10th June, 2022 (Friday)**.
- The Bidders are requested to give their best and final prices for all or any one lot as no negotiations on the prices are allowed.
- All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority (KPPRA).

Note: The Programme Director reserves the right to reject any or all the bids as per provisions contained in Rule 47 of KPPRA Procurement Rules 2014.


