

EXPRESSION OF INTEREST (EOI)

Transaction Advisory Services for Public Private Partnership for Construction, Operation and Maintenance of Green field tertiary care hospitals in Kpk

1. The Health Department of Khyber Pakhtunkhwa (KP) intends to explore the option of establishing Greenfield Tertiary care hospitals across KP for increasing the scope and coverage of healthcare services for general population of Kpk. For this purpose, the department intends to hire Consultancy services of a firm with a sound track record for designing and implementing PPP models for establishing and operating greenfield tertiary care hospitals and delivering related transactional and advisory services
2. EOIs are invited from Consulting firms, Companies, Consortiums or Joint Ventures having relevant expertise in the said assignment. The interested firms may submit their EOIs (One Original & One Copy) in sealed envelope by registered mail or in person at the address given below. Last date for submission of EOIs is 12-12-2021 at 03:00 PM (PST) and shall be opened on the closing date at 03:30 PM on the same venue in the presence of representatives of the firms who may choose to attend the EOI opening meeting.
3. The requirements for prequalification of consulting firms are as under:
 - I. Certificate of registration with concerned professional body from their country of origin.
 - II. Copy of registration with Security Exchange Commission of Pakistan (SECP) or Registrar of firms/relevant authority/institution.
 - III. Copy of Registration with Income Tax Department / NTN / GST.
 - IV. Audited statements of accounts for the last three (03) years
 - V. A brief/brochure of the Company highlighting relevant expertise
 - VI. List of similar projects (at least 2) completed by firm or core experts/team employed by the firm during the last 10 years indicating total cost of such works and cost of consultancy services received against those works along with date of start & completion.
 - VII. List of permanent professional staff along with CVs of relevant core staff showing project wise experience with exact time duration for each project. Maximum size of each CV should be 4 pages.
 - VIII. A certificate / affidavit that the firm is not blacklisted by any public sector organization in & outside Pakistan.
 - IX. A certificate / affidavit that the firm has not been or involved in litigation during the last ten (10) years with any public sector organization in & outside Pakistan



in favor of Health Department during office working hours from the date of publication of this advertisement up to one day before the closing day. The EOIs of only those firms shall be acceptable who had purchase signed copy of EOI Document from the Procuring Agency.

5. The EOIs shall be evaluated as per KP Procurement Regulatory Authority (KPPRA) Rules, 2014 (Amended up to 2021). The Interested firms shall be informed, in due course of time about the result of the evaluation of EOIs.
6. The written queries related to EOI document, received from the firms (minimum 03 days before the closing date), would be responded.
7. The Request for Proposal (RFP) shall only be issued to prequalified Consulting firms under this EOI.
8. The Department reserves the right to reject all EOIs under the relevant provision of KPPRA Rules, 2014.
